The Office of the Telecommunications and Radiocommunications Regulator (TRR) was established by an Act of Parliament called the Telecommunications and Radiocommunications Regulation Act 2009 ("the Act"). The Act mandates TRR to regulate the telecommunications and radiocommunications sector. It, and the Government's Universal Access Policy (UAP), give TRR the responsibility to implement the roll out of universal access provision.

TRR is seeking submissions from qualified individuals or companies to contract with TRR for the provision of several tenders. This is the second scheduled group of tenders for assorted goods and services related to the UAP programme. These programmes are funded by the Australian Government through donor funding to the UAP Fund of which TRR is the trustee.
