#### Penalty Notice Regulation Order No. 55 of 2017

In exercise of the powers conferred on me by section 32A of the Water Resources Management Act [CAP 281], I, the Honourable RALPH REGENVANU, Minister of Lands and Natural Resources make the following Order.

#### 1 Penalty Notice

The prescribed amount in respect of an offence committed under a provision of the Water Resources Management Act [CAP 281] are as set out in Schedule 1.


#### 2 Period to pay penalty

If a person served does not wish to have the matter determined by a Court, he or she must pay, within 30 days after being served with the Penalty Notice, to a person the amount of penalty prescribed under this Regulation and stated in the notice.

#### 3 Commencement

This Order commences on the day on which it is made.

## ORDER NO. 2 OF 2017

### Orders Relating To The Supply By Fidelity Communications Corporation Of Certain Additional Wholesale International Internet Capacity Notice No. 95 of 2017

TRR hereby makes the following Order, based on the findings and reasons in "TRR's Final Determination Concerning FCC's Requests For Approval Of Pricing For Several Sales Of Leased Submarine Cable Capacity".

1. TRR approves the sales by Fidelity Communications Corporation ("FCC") of the additional leased capacity referred to below on the ICL Cable (from Port Vila, Vanuatu to Suva, Fiji) on the condition that the capacity is supplied at a price not greater than the maximum prices set out below and that those maximum prices are applied from the date(s) the additional capacity began to be supplied by FCC.
  - i. For the supply to Digicel of [REDACTED] Mbps of additional capacity for a total of [REDACTED] Mbps of capacity, under a [REDACTED] term contract with a remaining term of [REDACTED], a maximum price of US\$ [REDACTED]/Mbps/Month.
  - ii. For the supply to Speedcast of [REDACTED] Mbps of additional capacity for a term ([REDACTED]), a maximum price of US\$ [REDACTED]/Mbps/Month;
  - iii. For the supply to TVL of [REDACTED] Mbps of additional capacity for a total of [REDACTED] Mbps of capacity on a [REDACTED] term until 30 April 2017, for a price of US\$ [REDACTED]/Mbps/Month.
  - iv. For the supply to TVL of a total of [REDACTED] Mbps of capacity on a [REDACTED] term from 1 May 2017, for a price of US\$ [REDACTED]/Mbps/Month.

- vi. For a supply to TelSat of [REDACTED] Mbps increasing up to [REDACTED] Mbps as needed, for a [REDACTED] term, a maximum price of US\$ [REDACTED]/Mbps/Month;
2. FCC is prohibited from supplying the above capacity, other than in compliance with Paragraph 1 above.
3. Within 15 days, FCC shall provide the following information to TRR:
- i. For of each of TVL, Digicel, TelSat and Speedcast, the date(s) on which FCC began to supply additional or different capacity to that being supplied as at 15 February 2017, and the amounts of additional or different capacity supplied on each such date;
4. By 7 June 2017, FCC shall provide TRR with the invoices or other records of FCC showing the amounts charged or incurred by each of Digicel, TVL, Speedcast and TelSat for any capacity supplied by FCC on the ICL Cable during the period from 1 March 2017 - 31 May 2017.






