

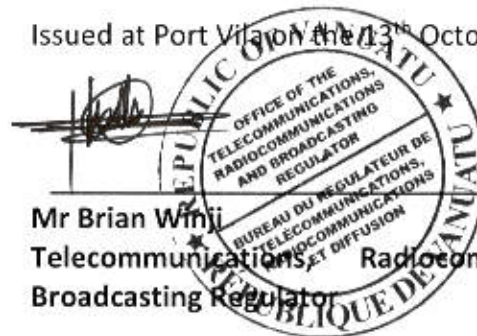


Broadcasting Licence

Pursuant to the exercise of the powers conferred under section 7 of the Telecommunications, Radiocommunications and Broadcasting Regulation Act No. 30 of 2009, as amended by Amendment No 22 of 2018 (the **Act**), I Brian Winji, the Telecommunications Radiocommunications and Broadcasting Regulator hereby issue a Broadcasting Licence to the person named at Item 1 of Schedule 1 of this Licence.

1. The person named at Item 1 of Schedule 1 of this Licence (hereinafter referred to as "the Licensee") who shall provide a broadcasting service in accordance with:
 - (i) The Telecommunications, Radiocommunications and Broadcasting Regulation Act No.30 of 2009 as amended by Amendment No 22 of 2018, herein referred to as the "Act";
 - (ii) Radio Apparatus and Spectrum (Fees) Regulation 2012; and
 - (iii) The Terms and Conditions of this Licence.
2. This licence comes into force on the date shown at Item 4 of Licence Schedule 1 and remains in force until the expiry date shown at Item 5 of Licence Schedule 1.

The operation of broadcasting services is authorised by this licence for the geographic area indicated in Schedule 3.

LICENCE SCHEDULE 2

TERMS AND CONDITIONS

3. General

The licensee shall operate a broadcasting facility for the provision of broadcasting services in accordance with:

- (i) The general provision of PART 3A on Broadcasting Licence as amended by Amendment No 22 of 2018 (the **Act**);
- (ii) Section 16A (4) of the Amendment No 22 of 2018;
- (iii) This Broadcast Licence Terms and Conditions.

4. Broadcasting station and transmitter sites

The licensee shall ensure that prior to the operation of broadcasting devices under this Licence in the geographical area identified in Schedule 3 to this Licence, the licensee shall submit to the Regulator details of the site, such as geographical coordinates, spot frequencies of transmitters, radiated power and target service area.

5. Liability to pay fees and charges

Subject to regulations made under section 16C (2) of the Act, the licensee shall meet all obligations to pay fees and charges fixed by the Regulator in respect of this licence.

6. Amendment and revocation of licence

The conditions of the Licence may be varied or revoked or further conditions will be added as set out in section 16E of the Act.

This Licence may be revoked or suspended as set out in section 16F of the Act.

7. Licence Renewal

The process for renewal of this Licence shall be carried out as provided for in the Act.
