

**INTERCONNECTION AMENDMENT AGREEMENT 2019**

---

**BETWEEN:** Digicel (Vanuatu) Limited (“Digicel”)  
**AND:** Telecom Vanuatu Limited (“TVL”)  
each a “Party” and together the “Parties”.

**RECITALS**

- A. The Parties have entered into a Network Domestic Interconnection Services Supply Agreement that has a Commencement Date of 1 April 2014 (“**Domestic Interconnection Agreement**”).
- B. The Parties, by an ‘**Interconnection Amendment Agreement 2018**’, amended the ‘**Domestic Interconnection Agreement**’ to, in effect, extend its Term by one year.
- C. The Parties now wish to further extend the Term of the Domestic Interconnection Agreement and retain the present Charges under Schedule E of the said Agreement.

**IT IS HEREBY AGREED**

- 1. Schedule A, Part A Clause 1.25 of the Domestic Interconnection Agreement shall, with effect from 31 March 2019, be substituted with the following:

“1.25 Expiry Date means the date six (6) years after the Commencement Date, unless earlier terminated in accordance with this Agreement.”

- 2. For the avoidance of doubt, other than those amendments specified above, all other terms of the Domestic Interconnection Agreement remain in full force and effect, unaltered.

3. For the avoidance of doubt, Chargeable Mobile Calls and Chargeable Fixed Calls will be charged for the full period of the Call.
